→ NSAIDs are side effect like increase the risk of gastrointestinal problem.

- Also stomach, bleeding or other complication NSAIDs are not used.
- NSAID can cause risk to the cardiovascular disease.

Diclofenac = High-dose can cause the gastrointestinal complication.

Naproxen = High dose - higher risk of complications

proton pump inhibitors :-

- Are not prescribed due to risk of bone fractures.

SOM NSAIDS :-

→ Are also not prescribed due to heart attack and strokes can cause.

→ There are various locally applied medications such as topical analgesics like.
