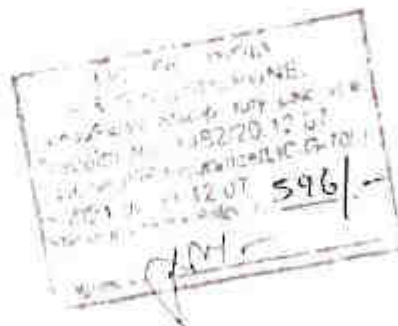

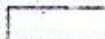

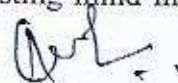
Day 4: Dr. Debapriya Dutta covered the basic information about "Research, Innovation and Education: Troika for Development during Amrit Kal"

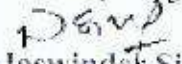

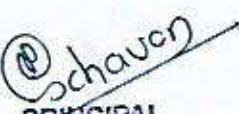
