Objectives:

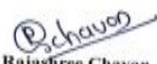
1. To address student complaints related to academics, examinations, administration, facilities or behavior.

Mechanism and Functions:

1. Students submit grievances through written applications, online portals or complaint boxes.
2. The SGRC acknowledges receipt of the grievance within a stipulated time.
3. The grievance is reviewed and categorized by the committee.
4. Concerned parties (students, faculty or staff) are called for discussion if required.
5. The committee investigates the issue following institutional rules and guidelines.
6. A fair decision is taken and communicated to the student.
7. Records of grievances and resolutions are maintained for transparency and improvement.

Expected Outcomes:

1. Timely and effective resolution of student grievances.
2. Increased student satisfaction and trust in the institution.
3. Improvement in institutional policies and practices based on feedback.
4. Reduction in conflicts and misunderstandings on campus.
5. Creation of a positive, inclusive and student-friendly learning environment.

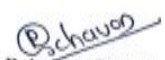
